- *By **stock transfer**. Please see the form, “HOW TO MAKE A STOCK OR MUTUAL FUNDS DONATION” for more information, which may be obtained at www.stmarks.net/about/financial.html, or by calling the Parish Administrator at 202-543-0053 x 305.*
- *By **automatic payroll deduction**. This must be arranged with your employer. Also, please complete the form, “NOTICE OF PLEDGE PAYMENT BY PAYROLL DEDUCTION,” which may be obtained at www.stmarks.net/about/financial.html, or by calling the Parish Administrator at 202-543-0053 x 305.*
- *By **automatic deduction from a bank account**. Please complete the form, “AUTHORIZATION FOR 2008 PLEDGE PAYMENT BY AUTOMATIC CHECKING ACCOUNT DEDUCTION,” which may be obtained at www.stmarks.net/about/financial.html, or by calling the Parish Administrator at 202-543-0053 x 305*
 - *Note that this form must be completed every year, even if continuing automatic deductions from the previous year.*
 - *Also note that to begin automatic deductions in January 2008, you must return the form (and voided blank check) with your pledge form, before December 7, 2007.*
