### VISION 2020

Kenn Allen and Mike Townsend reported that construction is done and management of the building is now in the hands of the Junior Warden and the Fabric Committee. They will report on finances at February meeting.

Action: To pass the following Resolution of Appreciation:

# BY-LAWS AMENDMENT ON MEMBERSHIP

Doris Burton, Membership Chair, and Mike Townsend, Stewardship Chair, reported on difficulties with getting members to pledge and are proposing a change in By-Laws to be more flexible how individuals become members.

Action: The Vestry shall ask the Parish, at the March 15 Annual Meeting, to approve the following amendment to the Parish ByLaws, with the understanding that the change shall take effect on April 15, 2015: That Article I, Section 101, be revised to read: "Definition of Membership: Every person above fifteen years of age is a member of St. Mark's Parish for purposes of an election and has the right to vote if, at some time, in the twelve (12) months preceding an election, that person has made a financial contribution to the Parish and (a) been recorded in the register of the Parish as a member of the Protestant Episcopal Church or (b) affirmed her/his wish to be a member in a manner as determined by the Vestry of the Parish."

Motion: Mary Thuell. Second: Amy Kovac-Ashley. Approved unanimously.

### **FINANCES**

Treasurer Penny Hansen briefed the Vestry on Parish finances and the budget. See Attachments 1 [Year End Treasurer's Report] and 2 [Finance Committee Budget Proposal]. The Vestry discussed the Parish's financial situation at length and agreed to vote on the budget by electronic mail. The Finance Committee will be considering the following proposal: "Beginning on January 1, 2015, it shall be the policy of St. Mark's Church to devote the proceeds of all bequests, which are not specifically targeted by the bequester to other approved activities of the church, to paying down the principal of the loan now held by the National Capital Bank of Washington."

Action: Vestry expresses extreme appreciation for Treasurer's and Finance Committee's extraordinary efforts to put together information for the 2015 budget.

Motion: Mary Thuell. Second: Gwen Dillard. Approved unanimously.

### YOUTH DIRECTOR SEARCH

Action: The Vestry approves the formation of a Search Committee for Director of Youth and Family Ministry, to be chaired by Steve Dalzell and including as members Beth Mahood, Mary Freed, Kris Humphreys, Ken Johnson and Julie Murphy. It charges this committee to identify, prioritize, and present to the Vestry three candidates to fill the DYFM position, with a goal of completing these actions no later than 26 April 2015.

Motion: Steve Dalzell. Second: Pam Lacey. Approved unanimously.

### OTHER BUSINESS

Gratitude for Paul's Stole

Action: The Vestry expresses its appreciation for Marcia Knutson's efforts to create a gift sole for Paul Abernathy on the occasion of its retirement, crafted in part from gifts of fabric from parishioners and friends.

### Minutes

# **Attachment 1: Treasurer's Report**

### **Financial Situation**

### • 2014 Income:

- o Operating budget required ~ \$72,000/month \$884,000 total
- o Received ~ \$66,000/mo \$794,000 total (including one-time addition of \$36,000 to refund 2013 trailer costs)
- o Vision 2020 \$222,000
- o Designated funds \$103,000
- o Possible reasons for shortfall
  - Concern about Rector change
  - Financial competition with Vision 2020
  - Long time parishioners retiring/moving
  - Constraints on programs from building construction
  - Fewer events (weddings, other outside use of buildings)
  - Port-a-potties
  - Others?

### • 2014 Expenses:

- o Operating budget required ~ \$72,000/month \$884,000 total
- o Actual costs tracked budget very closely all year \$888,000 total; Income loss was caused primarily by pledge shortfall of \$80,000, highest in at least 16 years. Usually it is 3-4%.
- <u>2015 Budget</u> Propose expenditures of \$874,200 (see attachments) and possibility of a balanced budget, while adding numerous large expenditures loan payments, unities, property insurance, search, transition, Interim Priest, youth director, etc. One year budget only 2016 will have to be significantly larger.

#### **Other Finance Committee information**

- All of Paul's final financial transactions have been completed including the \$31,250 sabbatical payment from Parish Reserve (70500)
- Committee reviewed Fund Raiser data for 2013 & 2014, and does not recommend vestry "tithe" motion at this time due to too small an impact on budget (see attachment)
- 2014 contribution statements sent to parishioners last week (thanks to Susan Block)
- On January 29, Committee will meet with Washington Capital Bank to discuss loan and transfer accounts from V2020 to vestry bank account.
- 2012 Audit received, reviewed and sent to Diocese
- New form for space use approved and new designated account set up for Maintenance Services
