TREASURER'S REPORT

St. Mark's is on budget for the year. Another \$12K payment made to Line Of Credit - being paid off as pledges come in. Hoping for some substantial pledge income in the next couple of months and will continue to pay off LOC.

DRAFT 2020 Operating Budget inputting numbers as received in response to call. \$129K estimate deficit in 2020 budget. \$44K deficit in 2019 budget was made up by surpluses from the previous year. NEXT month's DRAFT budget should better reflect projected end-of-year income and canvass status. **Vestry can review and consider places in budget for change at December meeting.**

Alix P noted that last year \$890K targeted, \$860K pledged and more was brought in. Pledges need to increase by +3% to hit \$890K target. \$890K will be \$129K short of DRAFT budget. Considerations:

- · Building maintenance is a major expense.
 - Review Maintenance Contract & Options
- · 40% have already pledged without requesting additional 3% pledge letter coming out now.
- · New members don't pay as much.
- · Relocation fees for new Ass't Rector may be less than budgeted (\$500 vs. \$5,000.)
- · No plan to increase the canvass goal at this time.
- · Jr. Warden informally compared rentals in area: Baxter Hall rates & Hill Conference Rooms @ \$189/hour are fair / Nave rental could be higher. Addt'l comparables research could be informative.
- · Christian Education Classes No Longer charge a \$25 fee.
 - o Penniman Fund funds weekends for Sunday School & Adult Class Teachers
- $\cdot~$ \$10K reserve for Sabbatical (Michele M. skipping 2020 hold as line item) and Building \$5K, respectively
- · Youth
 - o Children's Choir Director
 - Architecture Ministry (Shaye W.)

Alix P moves to approve the Treasurer's Report, Christina H seconds. Report approved by unanimous vote.
