# BY-LAWS ST. MARK'S EPISCOPAL CHURCH +CAPITOL HILL, WASHINGTON, D.C.

#### **Article I Members**

- **101. Members** Every person above fifteen years of age is a member of St. Mark's Parish for purposes of an election and has the right to vote if, at some time, in the 12 months preceding an election, that person has made a financial contribution to the Parish AND
- (a) been recorded in the register of the Parish as a member of the Protestant Episcopal Church

  OR
- (b) affirmed her/his wish to be a member in a manner as determined by the Vestry of the Parish.

# **Article II Parish Meetings**

- **201. Annual Meetings** The Members of the Parish will hold Annual Meetings on a date the Vestry shall designate between January 1 and March 31 of each year. At the Annual Meeting of the Parish the members voting must elect the Wardens, Members of the Vestry and a Lay Delegate by written ballot, and will transact such other business as properly comes before them.
- **202. Notice of Annual Meeting** The Rector must give notice of the annual meeting at least one month before the day of the meeting by notice posted on the church bulletin board, in the worship bulletin, and on the parish website. In the Rector's absence or failure to act, the Senior Warden must give the notice. The notice shall specify whether the meeting shall be in-person, exclusively virtual, or in-person and virtual ("hybrid"). If the meeting is partially or completely virtual, the notice shall provide the information necessary to attend the meeting virtually
- **203. Quorum** Twenty percent (20%) or more of the members of the Parish constitute a quorum for the transaction of business at any meeting of the members of the Parish. If there is no quorum at the meeting, the members present must adjourn. The Rector (or Senior Warden, as appropriate) must give at least ten days notice of the reconvening of the adjourned meeting as required in Section 202.
- **204. Presiding Officer and Secretary** The Rector, or in the Rector's absence or failure to act, the Senior Warden, will call to order and preside at the Annual Meeting. The Clerk will be the Secretary of the meeting. If the Clerk is not available, then the presiding officer will appoint instead a member of the Parish to serve as Secretary of the meeting. The Secretary of the meeting will (1) upon challenge, assist the Vestry to determine who of those present are members, (2) distribute the minutes of the previous meeting, and (3) take and record the minutes of the meeting, including a record of any votes.
- **205. Special Meetings** A special Parish meeting may be called by the Rector, by a majority of the Vestry, or by petition of (50) voting members of the Parish, with at least ten days notice posted on the bulletin board, in the worship bulletin, and on the Parish website. If the special meeting is to consider a change to these By-laws, then at least thirty days' notice shall be given. The notice shall specify whether the meeting shall be in-person, exclusively virtual, or in-person and virtual ('hybrid'). If the meeting is partially or completely virtual, the notice shall provide the information necessary to attend the meeting virtually. The notice also must state the business that the Parish will consider at the special meeting. No vote may be taken on any business not included previously in the notice.

#### **Article III The Vestry**

## **301.** Vestry.

**A.** In general. The Vestry consists of the Rector, the Senior Warden, the Junior Warden, and nine Members of the Vestry elected to the Vestry in accordance with section 403. Any priest or deacon who is a full-time salaried employee of the Parish will have a seat on the Vestry, but no vote.

**B.** Vestry members under 18. Vestry members under the age of 18 may not constitute a majority of the Members of the Vestry, nor may they be included in the computation of a quorum or vote on the acceptance of any contractual obligation of the Vestry.

- **C. Definition**. For purposes of these By-laws, the term "Member of the Vestry" means the nine individuals elected to the Vestry in accordance with Section 403.
- **302. Vestry Meetings.** The Vestry will hold stated meetings not less than once each month from September through June and at other times as the Vestry may determine by resolution. The Rector, the Senior Warden, or one-third of the Members of the Vestry may call Special meetings of the Vestry by delivery of not less than three days' notice to the Senior and Junior Wardens and to each Member of the Vestry.
- **303. Vestry Quorum** Any four (4) elected Members of the Vestry (including the Wardens) constitute a quorum for the transaction of Vestry business. The act of the majority of the eligible voting Members of the Vestry present at the meeting will be the act of the Vestry.

# Article IV Election of Wardens, Members of the Vestry, Lay Delegates, and Officers of the Vestry

- **401. Eligibility** Candidates for the positions of Wardens, members of the Vestry, Officers of the Vestry and Lay Delegates must be members of the Parish. See section 101 of these By-Laws. In addition, candidates for Lay Delegates and Alternate Delegates must be confirmed communicants of the Protestant Episcopal Church.
- **402. Nominations** No later than two months before each Annual Meeting, the Rector (or the Senior Warden in the Rector's absence or failure to act), with the approval of the Vestry, must appoint a Nominating Committee, consisting of the Senior and Junior Wardens, all outgoing Members of the Vestry, and at least two members of the Parish who are not Members of the Vestry. The Nominating Committee will place in nomination at the Annual Meeting at least one qualified candidate for each position of Warden, Member of the Vestry, and Lay Delegate open for election. The report of the Nominating Committee listing and identifying the candidates selected by it, together with the voting procedure, must be posted on the church bulletin board and on the Parish website at least one month before each Annual Meeting (and, if feasible, in the church newsletter). At the Annual Meeting the Nominating Committee will make its report, which action will place in nomination the candidates that it selected. Following the report of the Nominating Committee other nominations may be made from the floor.
- **403.** Election of Wardens, Members of the Vestry and Lay Delegates Election of the Senior Warden, the Junior Warden, the Members of the Vestry, and a Lay Delegate is by written ballot (unless unopposed) by a simple majority of the members of the Parish voting at the Annual Meeting. The members of the Parish will elect three Members of the Vestry to serve three-year terms at each Annual Meeting, and may fill any vacancy on the Vestry created by the death, resignation, or removal of any Member of the Vestry before the end of that Member's three-year term. The Members of the Parish will also elect one Lay Delegate to the Regional Assembly and the Convention of the Diocese of Washington, to serve a three-year term, and may fill any vacancy of the three Lay Delegates created by the death, resignation, or removal of any Lay Delegate before the end of that Delegate's three- year term.

#### **404 Tenure and Vacancies**

- **A. Wardens.** Except as provided in paragraph D.1, the Senior Warden and the Junior Warden will hold office for a two-year term, which begins at the Annual Meeting in which they are elected and which extends to the Annual Meeting two years hence. The Wardens may be elected to a one-year extension on their term before becoming ineligible to serve in the same office until the lapse of two years after the end of such terms.
- **B. Vestry.** Except as provided in paragraph D.2, Members of the Vestry will hold office for a three-year term, which begins at the end of the Annual Meeting in which they are elected. After a Member of the Vestry serves a three-year term or over one-half of it, that person will not be eligible to be a Member of the Vestry until two years after the end of that three-year term.
- **C. Lay Delegates.** Except as provided in paragraph D.2, Lay Delegates will hold a three-year term, which begins at the end of the Annual Meeting in which they are elected. After a Lay Delegate serves a three-year term or more than one-half of it, that person will not be eligible to be a Lay Delegate until two years after the end of that three-year term.

#### D. Vacancies.

- 1. Should a vacancy occur in the office of Senior or Junior Warden by death, resignation, or removal of the Warden before the end of the Warden's term, the Vestry may elect a Member of the Vestry to fill the vacancy until the next Annual Meeting.
- 2. Should vacancies occur on the Vestry or among Lay Delegates by death, resignation, or removal of any Member of the Vestry or Lay Delegate before the end of the Member's or Lay Delegate's three- year term, the Vestry may appoint a member of the Parish to fill the vacancy until the next Annual Meeting, when the members of the Parish will elect a member or Lay Delegate to fill the vacancy. The newly elected Member of the Vestry or Lay Delegate may hold office only for the remainder of the term to which he or she succeeds.
- **E. Eligibility.** No person completing five years' continuous service as a Member of the Vestry or as a Warden, or as both, is eligible to serve on the Vestry or as Junior or Senior Warden for two years. Members of the Vestry are not eligible for election as Warden before they complete their terms as Members of the Vestry or they resign from the Vestry.

# 405. Election of Clerk, Treasurer, Assistant Treasurer, Other Vestry Officers, and Alternate Lay Delegates

- **A. Officers.** At the first meeting of the Vestry after the Annual Meeting, the Vestry will elect by simple majority a Clerk, a Treasurer, and Assistant Treasurers, and such other officers of the Vestry as the Vestry deems the Parish needs.
- **B.** Alternate Delegates. At the first Vestry meeting after the Annual Meeting, the Vestry will elect one or more Alternate Lay Delegates to the Regional Assembly and the Convention of the Diocese of Washington. An Alternate Lay Delegate designated by the Vestry assumes the duties and responsibilities of a Lay Delegate when the Lay Delegate is absent.
- **C. Terms of Office.** All Vestry Officers and Alternate Lay Delegates serve one year or until their successors have been elected and begin to serve. A person may serve three consecutive terms in the same office before becoming ineligible to serve in that office for two years. A person completing five years of continuous service in Vestry offices, including that of lay delegate or alternate, becomes ineligible to serve in any Vestry office for two years.
- **406. Power to Remove** The Vestry may remove any officer elected by the Vestry, with the exception of the Clergy, at any time by the affirmative vote of two-thirds of the whole Vestry.

# Article V Powers, Duties, Obligations, and Rights of Wardens and Vestry

# **501.** Duties, Obligations, and Rights of Wardens The Senior and Junior Wardens will:

- 1. serve on the Vestry and generally perform and exercise all duties and obligations as are required by the Vestry, these by-laws, the laws of the District of Columbia, the Maryland Vestry Act of 1798, as in effect in the District of Columbia, and the Canons and Constitution of the Episcopal Church and the Diocese of Washington; and
  - 2. have all rights and obligations of Members of the Vestry.

#### **502.** Powers of the Vestry.

**A.** In General. The Vestry has power to do and cause all things to be done that the Parish must do as a corporate body.

#### **B. Specific Powers.**

- 1. Rector. The Vestry has express power to issue calls to the Rectorship of the Parish under the provisions and requirements of the Canons and Constitution of the Episcopal Church and the Diocese of Washington. The Vestry may agree and contract with the Rector on such terms and conditions as it deems reasonable and proper. If there is no Rector, the Senior Warden will administer the Parish.
- **2. Committees**. The Vestry will establish committees that it deems desirable and will establish procedures and guidelines governing the selection and tenure of the committee leaders and members.
  - 3. Audit of Parish Books. At its December meeting each year the Vestry will designate

either a Certified Public Accountant or any competent person or persons not directly connected with the financial affairs of the Parish and not Member(s) or Officer(s) of the Vestry to audit the Treasurer's books and records for the then current calendar year.

- **4. Property**. The Vestry may sell, alienate, or encumber any real property owned by the Parish only if:
- a. the Vestry has the consent of both Wardens, at least four (4) Members of the Vestry, and the Rector, except that if there is no Rector in the Parish, the Vestry must obtain the consent of the Bishop of the Diocese of Washington; and
- b. the Vestry has the consent of the Bishop and the Standing Committee of the Diocese required in Canon 6 of the Episcopal Church and Canon 29 of the Diocese of Washington.
- **503. Duties of the Vestry** The Senior and Junior Wardens and Members of the Vestry serve on the Vestry and perform and exercise all duties and obligations as are, or may be, required by these By-Laws, the Maryland Vestry Act of 1798 as in effect in the District of Columbia, and the Canons and Constitution of the Episcopal Church and the Diocese of Washington. Their duties include:
- 1. act as judges at the Annual Meeting of the Parish, including deciding any issue concerning the inclusion or omission of any person on the list of qualified voters,
- 2. manage, control, and direct, with power to sell, alienate, encumber, or transfer all property of the Parish as provided in section 502;
- 3. elect a Rector, Assisting Clergy, Register, Treasurer, Assistant Treasurers, Alternate Lay Delegates, and other officers that the Vestry needs.
  - 4. provide necessary books and records for the Register, Treasurer, and Assistant Treasurers.
- 5. file before March 1 of each year with the District of Columbia Government a report showing the purposes for which the tax-exempt property of the Parish was used during the preceding year;
  - 6. make rules and regulations for the government and support of the Parish;
- 7. exercise the powers of a corporation and body politic as prescribed by the Maryland Vestry Act of 1798, as in effect in the District of Columbia, and the laws of the District of Columbia; and
  - 8. sue and be sued on matters involving the Parish.

# 504. Duties of the Clerk The Clerk shall:

- 1. act as a secretary to the Vestry and at the Annual or special parish meetings; and
- 2. generally act and perform by the provisions of the Canons and Constitution of the Episcopal church and the Diocese of Washington relating to clerks and secretaries of Vestries and by the laws of the District of Columbia.

# 505. Duties of the Treasurer

- A. Treasurer. The Treasurer will:
  - 1. act under the supervision of the Vestry;
- 2. except as otherwise directed by the Vestry, have charge and custody of all the monies and valuables of the Parish;
- 3. be responsible for the keeping of accurate and adequate records of the assets, liabilities, and financial transactions of the Parish; and
- 4. in general perform all the duties incident to the office of Treasurer and such other duties as the Vestry may assign to the Treasurer.
- **B. Vacancy.** In the absence of the Treasurer, or the Treasurer's inability or failure to act, the Treasurer's duties will be performed by an Assistant Treasurer that the Vestry will designate after consultation with the Treasurer
- **C. Bond.** The Treasurer and the Assistant Treasurer designated by the Vestry under subsection B must furnish a corporate bond or surety in an amount that the Vestry will determine. The cost of the bond or surety will be paid by the Diocese of Washington, or, if not, by the Vestry.

#### **Article VI Rector**

**601. Duties.** In matters concerning the duties of Rectors or Ministers, the dissolution of pastoral relations, and the filling of vacant cures, the Canons and Constitution of the Episcopal Church and the Diocese of Washington govern the Rector and the Vestry of the Parish.

#### **Article VIII Amendments**

**701. Procedures.** The members of the Parish may amend, modify, or repeal these By-Laws by vote of two-thirds of the members of the Parish voting at any Annual or Special Meeting of the Parish, provided, that the Vestry gives notice of the proposed amendment, modification, or repeals by posting the proposed amendment, modification, or repeal on the Parish bulletin board and on the Parish website at least one month before the Annual Meeting.

**702.** Effect These By-Laws have full force and effect when the members of the Parish adopt and replace the current By-Laws and supersede any By-Laws of the Parish that may be in effect before the members adopt these By-Laws.

# MINUTES OF THE 2023 ANNUAL MEETING March 5. 2023

The Annual Meeting was held in person and virtually via Zoom video conferencing platform.

The Register, Shay Waye, announced the presence of a quorum (64). A two-thirds majority was 83. Attendance online and present was 127.

Motion (David Deutsch) and seconded (Jane Byrne) to elect Jim Brooks as Senior Warden by acclamation. Motion carried.
- 2. Todd Thorpe was announced as a candidate for the position of Vestry for a 3-year term. Additional nominations from the floor were called. Seeing none, it was moved (Doris Burton) and seconded (Jan Lipscomb) to nominate Todd Thorpe to Vestry, 3-year term. Motion carried.
- 3. Meg Platt was announced as a candidate for the position of Vestry, 3-year term. Additional nominations from the floor were called. Seeing none, it was moved (Nat White) and seconded (Marika Klein) to nominate Meg Platt to Vestry, 3-year term. Motion carried.
- 4. Travis Beaty was announced as a candidate for the position of Vestry, 3-year term. Additional nominations from the floor were called for. Seeing none, it was moved (Jeb Ory) and seconded (Rita Ossolinski) to nominate Travis Beaty to Vestry, 3-year term. Motion carried.

It was moved (David Deutsch) and seconded (Marika Klein) to close nominations of Vestry members. Carried.

It was moved (Doris Burton) and seconded (Pam Lacey) to elect the three nominees - Todd Thorpe, Meg Platt, and Travis Beaty as Vestry members for a 3-year term by acclamation. Motion carried.

The newly-elected Senior Warden and Vestry members were introduced and given time to make brief remarks.

Maureen Shea was announced as a candidate for the position of diocesan delegate for a 1-year term. Additional nominations from the floor were called. Seeing none, it was moved (Michele Morgan) and seconded (David Deutsch) to nominate Maureen Shea as diocesan delegate, 1-year term. Motion carried. It was moved (David Deutsch) and seconded (Rob Hall) to elect Maureen Shea as diocesan delegate, 1-year term by acclamation. Motion carried.

It was moved (Rob Hall) and seconded (Doris Burton) to close elections. Motion carried.

# MINUTES OF THE ANNUAL MEETING February 4, 2024

Draft—For approval at the 2025 Annual Meeting

The annual parish meeting was called to order by the Rector. The opening prayer was offered by The Rev. Thom Sinclair.

The presence of a quorum was announced by Mary Cooper, temporary clerk. There were 140 voting members on site and 15 attending remotely.

The minutes of the 2023 meeting were approved with Rob Hall moving and David Deutsch seconding approval.

**NOMINATION OF CANDIDATES:** The members of the Nominating Committee were retiring Vestry members Jeb Ory, Chris Berendes, and Katherine Buchanan. Chris Berendes reported eight candidates for Vestry and Junior Warden, representing the diversity of the parish membership. He expressed gratitude from the Committee for those who had stepped up to assume positions of leadership.

Jeb Ory presided over the election process, noting that this was the first contested election since 2014.

**ELECTION OF THE JUNIOR WARDEN:** Martha Huizenga was nominated by the Committee. There being no nominations from the floor, she was elected by acclimation.

**DIOCESAN DELEGATES:** Katherine Buchanan and J.R. Randall were nominated by the Committee. There being no nominations from the floor, they were elected by acclimation.

**MEMBERS OF THE VESTRY:** The names of the six candidates proposed by the Nominating Committee were proposed. There being no nominations from the floor, the six nominees each spoke briefly about their interest in serving on the Vestry and responded to a single question posed by the Nominating Committee. The nominees were: Kristina Keenan, Amilcar Portillo, Elizabeth Becker, Doug Padgett, Janet Vail, and Mitchell Wood.

The voting process was explained which allowed members to vote either in person or remotely and by paper ballot or electronically.

**SENIOR WARDEN'S REPORT:** While the votes were being counted, Jim Brooks addressed the meeting, expressing his appreciation to the Rector for the smooth process for operating the Annual Parish Meeting and to The Rev. Christopher Phillips for his service to the parish as he departs to become Rector of Redeemer+Bethesda. Jim also expressed appreciation for retiring Junior Warden, David Wellman, for retiring Vestry members Chris Berendes, Katherine Buchanan, and Jeb Ory, as well as retiring Treasurer Randy Marks, Clerk Shay Waye, and Diocesan Delegate Mary Nesnick. He thanked David Deutsch and Karen Falk for preparing the summary report distributed at the meeting.

The Senior Warden noted that the parish is bouncing back from the Covid lockdown with attendance having recently increased by 20%. However, membership is essentially flat and needs to grow. He reported the Vestry anticipated a small financial deficit for 2023 but there is actually a small surplus. The budget has been just over \$1 million for each of the last three years.

Among the signs of health he mentioned were outreach by the dance studio, support for immigrants, and the development of a new men's group. Many small groups are expanding. The parish retreat will return in June for the first time since the lockdown.

**JUNIOR WARDEN'S REPORT:** Retiring Junior Warden David Wellman reported that the building is safer. There are new thermostats and locks throughout as well as a new fire monitor. The Department of Homeland Security did a safety assessment and is helping with the cost of improvements. The closets have been cleaned out. Lighting in the nave still needs improvement. He expressed his appreciation for Parish Administrator Michael Gravlee for his support and assistance. The parish thanked David for his service with a standing ovation.

# **PROGRAM PRESENTATIONS:**

Christian Education: Annabelle Swift, Co-Director of Christian Education reported there are about 300 people signed up for classes and invited parishioners to join or suggest classes.

Social Justice: Edna Boone, Holly Kreuter, and Julie Murphy reported that the Social Justice Committee (formerly Outreach) seeks to lead St. Mark's in caring for vulnerable people through groups such as Everyone Home DC, Incarceration Justice, Gun Violence Reduction, Support for Migrants, Grate Patrol, Samaritan Ministry, collecting clothing and shoes for immigrants, and providing lunches for needy people.

**TREASURER'S REPORT:** Retiring Treasurer Randy Marks presented his report remotely from Asia, expressing his thanks to Bill Jordan and Frank Nickerson for their service to the Finance Committee and to Annick Milde (Financial Officer) for her support and assistance. He reported the budget had a small surplus in 2023 and the pledge goal had been met. Plate offerings did well and everyone stayed within budget. The Finance Committee has a list of places where additional funds could usefully be spent if additional income develops.

**ELECTION RESULTS:** The tellers announced the people elected to the Vestry for the next three years are: Doug Padgett, Kristina Keenan, and Elizabeth Becker.

The Rector presented gifts to the retiring Vestry members, officers, and Finance Committee leaders.

The closing prayer was offered by The Rev. Christopher Phillips and the meeting was adjourned.

#### **VESTRY**

#### **SENIOR WARDEN** *Jim Brooks (no report)*

#### **JUNIOR WARDEN** David Wellman

The Junior Warden is responsible for the use and upkeep of our building. Overall, I believe our facilities are in good shape. Our property-related financial categories accounts for about 20% of the annual budget. In 2023 we expended 98% of our budget in these building-related accounts.

We are hosting more activities in our building as we move beyond the Covid shutdown. This has increased our need for more cleaning and light repairs. In the last year we hired a new janitorial firm to clean. To reduce costs, we buy cleaning supplies and paper goods through a Cooperative.

Fall 2023: We received notification of a \$150,000 grant from the Dept. of Homeland Security to improve safety and security. The projects approved include: repairing our historic nave doors, installing new security hardware, installing lighting and cameras in our courtyard, and developing emergency response plans. This grant is a reimbursement type which requires us to perform the work before seeking reimbursement. We expect the work to occur in the latter half of 2024 and into 2025.

We also addressed security by rekeying 118 sets of doors in our facility and instituting management protocols to better track the distribution of new keys. This work included installing keypad locksets at our classrooms so we no longer need to distribute keys

We made a variety of repairs to maintain our building: work on our HVAC system included replacing a pump in the boiler system, replacing the heating core in the air handling unit serving Baxter Hall, and installing a UV sterilizer in the Elder's Room ductwork to reduce odors. We also replaced the freezer in the kitchen. Exterior work included trimming and fertilizing the trees in the courtyard.

With the help of the Endowment, we purchased a large flat-screen TV, a soundbar and a mobile cart to facilitate the hybrid classes and meetings that have become common. We purchased an Automatic Emergency Defibrillator (AED) and held a training session on its use. The AED is in the Foster Foyer adjacent to the restrooms. We hope to offer more classes for this lifesaving device in 2024.

As Junior Warden, I appreciate the help of many people keeping our building repaired and looking good. I thank Martha Huizenga, Manciple, for sharing the workload and independently managing much needed projects, and Jim Pittman, former Junior Warden (2018-2021), for help with repairs.

Michael Gravlee, Parish Administrator, has been invaluable fixing things when they break and in scheduling and managing our contractors. Charlie Rupp (JW, 1989-91) has freely shared his knowledge of the building and stepped up with his expertise of our building's fabric when problems arose.

Thanks to Kenn Allen and Maureen Shea for keeping the kitchen/Baxter Hall area tidy and lending a helping hand when asked. Kathryn Powers has worked hard to keep our courtyard and gardens looking great. And thanks to my Fabric Committee, Martha Huizenga, Jim Pittman, Kenn Allen, Doris Burton, Charlie Rupp, John Edwards, Don Gangloff, Michael Summey, Jack Richards and Melissa Zimmerman for their advice and counsel.

Finally, I would like to thank Reverends Michele and Chris for their encouragement and support.

They were actually \$161,589 or \$24,589 in excess of budget. We will receive \$24,589 less in payments on 2024 pledges than we might otherwise have expected.

The Vestry decided to include the \$24,89 in excess pledges as 2024 Income.

# **Financial Highlights**

- We received a clean audit for our 2022 financial statements meaning they accurately reflected the church's financial condition and results. We used a new auditor who performed very well.
- We filed for Employee Retention Tax Credit, which may lead to a large cash inflow towards the end of 2024.
- All reserves (operating, building, sabbatical) are invested in Vanguard Star Funds in hopes of generating higher returns over the long term.
- The Vestry adopted a policy that, absent contrary donor intent or other extraordinary conditions, all bequests will go into the Building Reserve Fund.
- Working with the Endowment Board, we have begun to utilize better available resources from the Endowment.
- We re-established our financial relationship with our Satellite Organizations (Dance, Music Studio, Yoga, Meditation, Players), all of which contributed generously in 2023 and have committed to do so in 2024.
- We made changes to increase transparency:
- We stopped using pass-through accounts, meaning that all income and expenses are reported in our financial reports.
- We separated Non-Budgeted Income and Expense accounts from budgeted accounts so the parts that Parish Managers and Staff manage were clearer.
- We made periodic reports to the parish via the E-Gospel and Weekly Announcements.
- We have raised concerns about the parish's long-term stability for Vestry and parish to consider:
   Pledge, plate, & building use income seem to be inadequate to fund high Core Expenses (for
   staff & building) and vibrant programs and outside ministries (Service & Social Justice and dioce
   san pledge).
- We need \$1 million per decade to maintain our building.
- It's unclear whether healthy growth can close the gap.
- We may need a new strategic vision with new income sources or lower expenses.

The Endowment was created by the Vestry in 2002. It provides a way for parishioners to contribute to the long-term needs of the church through donations to several funds (listed below). These funds support projects within specific areas of church life including its buildings and grounds. The Endowment does not pay routine expenses or supplement the operating budget, which is supported primarily by annual pledges.

A five-member board, approved by the Vestry, manages the Endowment. Their responsibilities include establishing individual Endowment Funds; accepting gifts, bequests and donations; investing the funds in a diverse and balanced portfolio in order to achieve stable growth; and distributing the fund's assets consistent with the Endowment and the individual fund charters.

Contributions and bequests are currently invested in the Vanguard STAR Fund (VGSTX), which follows a balanced investment approach by placing 60-70% of its assets in common stocks and 30-40% in bonds. It is a low-cost, well-managed fund that is appropriate for the Endowment's moderate to conservative investment goals. During the year 2023, the fund had an annual return of 17.1% (compared to a return of 24% on the S&P 500).

Each year an amount of each fund available for distributions is calculated based on 5% of the 3-year rolling average of the fund's valuation as of December 31 of that year. Available amounts that are not distributed in a given calendar year accrue and remain available for distribution in subsequent years. The sum of these two amounts—5% of the average fund valuation plus all accrued and undistributed amounts from prior years—constitutes the "distributable amount" of each fund. This method of disbursement computation is the most commonly used method in the non-profit world.

#### **Description of Funds**

**Building Preservation Fund:** Est. 1998 from sale of the rectory; fund provides for improvements to church facilities.

**Hoitsma Fund:** Est. 1981/gift from the Hoitsma family; provides for long-term building improvements not covered by the operating budget. (Ralph Hoitsma: SW,1968-1971; JW, 1965-68)

**General Fund:** receives general bequests and donations to support non-building related projects that further the overall mission of the church.

**Verna Dozier Fund:** Est. 2000 from funds donated, but not needed, for the Dozier clerestory window; provides scholarships for college-bound seniors at Dunbar High School. Among criteria for selection is a student essay describing a person who made a deep impression on him/her as he/she was growing up. The Dunbar Alumni Federation (DAF) selects the recipient(s).

**Craighill Dance Fund:** Est. 1984,gift from the Craighill family; supports the St. Mark's Dance Studio and includes the Beryl Martin Memorial Scholarship Fund for promising dancers. (Mary Craighill was the founder of the dance studio)

Arts Fund: Est. 2002; to receive bequests and donations to benefit the arts at St. Mark's.

**Holtkamp Organ Fund:** Est. 1998; provides for the capital needs of the Holtkamp Organ. The Music Director requests disbursements.

The Endowment charter also provides that the Endowment should set aside funds every year toward a periodic survey of the condition of the parish properties.

# 2023 Activity; Fund Balances; 2024 Distributable Amounts

In 2023, the Endowment paid out a total of almost \$43,000 for a variety of different projects, including digitizing parish records, rekeying the doors, building and equipment repairs, repair and polishing of the Victorian floor candelabra, and scholarship funds.

The table summarizes all activity (contributions and distributions) in each of the Endowment funds in 2023, as well as the corpus of each fund at December 31, 2023, and distributable amounts in 2024 based on the formula described above.

**CANVAS/STEWARDSHIP** *Katherine Buchanan and Meg Platt, Co-chairs*; Christopher Berendes, Jim Brooks; assistance from Todd Thorpe, Annabelle Swift, Jeb Ory, Jan Lipscomb, Jackie Bodie, Kenn Allen and Maureen Shea, Amber McDonald, Annick Milde (Financial Officer), and Michael Gravlee (Parish Administrator), The Rev. Michael Morgan, The Rev. Chris Phillips.

Our Stewardship Canvass for securing 2024 pledges was "Knitting the Canopy Together" and found its inspiration in Jesus' call to abide together, echoing our unwavering commitment to nurturing community and spreading God's grace and love. Our aim was ambitious: to collect \$1 million in pledges for 2024 to sustain our building, provide for our clergy and staff, and continue to offer opportunities for parishioners and community members to connect through fellowship, music, Christian education, social justice, and other avenues.

For the pledge drive, we have yet to realize our goal. We have, so far (February 2024) received 246 pledge units with pledged sums totaling \$899,286. We are encouraged by the increase in both pledged units and income from the 2023 Canvass, which had 238 pledging units by February 2023 and \$840,230 in pledged funds—which, as of February 2024, \$829,454 of the pledged \$840,230 has been fulfilled (and more anticipated to arrive in the months ahead). In 2024, we expect additional pledges and meaningful stewardship by the community to continue to trickle in. We will work actively throughout the spring, summer, and fall to cultivate further engagement.

As a committee, we are pleased with the results, which show marked growth over 2023. Given unexpected gifts that arrived in 2023 and changes in staffing in 2024, we expect the total expected income will provide for our needs. Still, we plan to continue our work throughout 2024 to deepen engagement—both personally and financially—so that we might increase the impact of our beloved community here on Capitol Hill.

**MEMBERSHIP** *Jeb Ory* (Chair), Karen Falk, Treasurer; Members: Todd Thorpe, Jeremy Sierra, Randy Marks, Kenn Allen, Amber Macdonald, Mitch Wood.

This past year, the Membership Committee focused on consistent execution of its mission:

To develop, implement, administer, monitor, refine and revise a year-round program for membership emphasizing our promise and commitment to provide a home and a community for parishioners and visitors alike. There are three guiding principles for the committee:

- 1. Membership is a year-round activity with a continual year-round focus.
- 2. Growing membership requires ambitious goals and buy-in and engagement from the entire parish, and particularly, from clergy, lay leaders, and staff.
- 3. Growing (and sustaining) membership depends on progressively increasing the engagement of each member in St. Mark's community, including involvement in worship, classes, events, and committee work.

The Committee meets monthly with an annual kick-off each January. Our goals for 2024 are to increase pledge units by 10% (up to 275), increase church attendance by 20% (up to 12,660, and to identify and grow our volunteer pool by 25%.

We have brought specific focus to seven major campaigns / events throughout the year:

- Planning and execution for public awareness for Easter/ Holy Week
- Engaging new and lapsed members for feedback
- Small steps for growth
- Planning and attending 4th of July Parade
- Planning and execution for public awareness of Back to Church and Blessing of the Animals
- Planning and execution of the Liturgy of Commitment
- Planning and execution for public awareness for Advent / Christmas

We continue putting out the welcome table, inviting people in, and envisioning a 2024 where we have greeters outside the nave doors to make sure that all who enter are welcomed.

#### **COMMUNICATIONS WORKING GROUP** Chris Berendes, Edna Boone

There were two major new efforts this year, both collaborative. Edna Boone, unofficial CWG member, identified 77 key web pages and worked with clergy, staff, and parish groups to get most of them - at least 80% - updated. Building on a first effort for Christmas 2023, we created a continually updated Sunday Services page, <a href="mailto:stmarks.net/sundays">stmarks.net/sundays</a>, with a detailed introduction to worship for first time visitors. We also created specific urls and QR-codes for printed publicity - our Christmas banner, yard signs, and door hangers - as a first effort to determine whether printed publicity translates into visits to stmarks.net.

As in years before, we added or edited 20 or more posts monthly to keep stmarks.net in sync with the E-gospel and with the announcements distributed on Sundays.

To support a large number of hybrid activities, we maintain stable, friendly web links for Sunday services, memorials (now generally live-streamed), and special events, such as a criminal justice-related meeting with Council Member Charles Allen.

Over the course of a year, 56% of the pages viewed help visitors track upcoming activities at St Marks (announcements, events, calendar), 7% of the page views relate specifically to Sundays (worship schedule, livestream, bulletins) and 6% to staff contacts and our vision statement.

**DIOCESEAN CONVENTION** (Jan 27, 2024); *Thomas Getman, Mary Nezenk,* Lay Delegates; *Rev. Michele Morgan, Rev. Patricia Catalano,* Clergy.

The Committee for Reparations report provided findings on the benefits to churches through the institution of chattel slavery. Rev. Peter Schell (Calvary+DC) reported the legacy of ongoing financial inequity of parishes in terms of endowment, per capita resources for clergy and distribution of wealth for developing reparations policy proposals.

The Report on Committee on Congregation Diocesan Stewardship and Support: Rev. Jessica Hitchcock, St Luke's+Bethesda: reported establishing a 'normative standard of annual financial commitment of a tithe of annual operating income in the direction of 10% as a canonical expectation."

#### Resolutions Adopted:

- 1. Parishes with deacons pay into the Church Pension Group a minimum of qualifying rate of \$25 per month plus assessment of 18% (\$25 + \$4.50 or \$29.50 per church per month for total of \$354 annually to ensure their service credit for years served.
- 2. Sacred Ground be established as one means of fulfilling required anti-racism training.
- 3. Migration with Dignity: EDOW advocates for Migration with Dignity, a set of immigration policies that assure equal and respectful treatment of all people including all migrants, refugees, asylum seekers, displaced persons, those who cross borders in search of opportunity in order to guarantee their welcome, protection and integration into our 'common human journey.'
- 4. Conditioning US Military Aid to Israel (introduced by delegate Thomas Getman): to ensure that US military assistance and arms not be used to perpetuate conflict, violate human rights or contribute to corruption, instability of violence.
- 5. In Solidarity with International Palestinian Boycott, Divestment & Sanctions Movement (introduced by delegate Mary Neznek): Modeling 2018 TEC resolution, EDOW will follow that policy to use corporate screen with companies profiting on illegal occupation of Palestinian land as means to ensure Israel complies with international law.

Note: We had been entitled to three delegates until Covid. Because our population was reduced, we now send only two delegates to Convention.

#### **ADVISORY COMMITTEES** Betsy Athey, Chair

These have been assisting our clergy, wardens, seminarians and staff since 1975. They are composed of a lay convenor and 4-6 parishioners who represent a microcosm of our community, are connected to parish life, and serve generally a 2-year term. Each committee supports a leader by offering to be a "sounding board," focusing on issues central to the work and life of the principal and providing feedback as requested. Regular monthly attendance, confidentiality, and the courage to "speak one's truth" are expected.


# **ELDERS** Betsy Athey, Bruce Sherman, Conveners

This group includes all former wardens and Directors of Christian Education. They meet upon the request of the wardens, co-directors, clergy or other parish leaders. An annual dinner for Elders and spouses is held, usually in the spring.

There are currently 55 Elders living in the area and active. Nationwide, 66 remain in contact and many continue to be deeply involved in church activities.

In September, we convened to enjoy our annual dinner. 28 Elders and spouses, along with Michele Morgan, attended. We honored our retiring Interim Senior Warden Louise Walsh, Co-Directors Keith Krueger, Karen Falk and continuing Co-Director Greg Niblett, and inducted/re-inducted them with deep gratitude and celebration into the Elders' ranks.

The Pilot Project for Lay Involvement in Worship Planning, started by the Elders, continued through 9 Sundays in 2023 and is expected to continue in 2024 (See Pillars: Worship for details)





# REPORTS FROM THE PILLARS

**Vergers** *Josie Jordan, Head Verger* A verger's duty is to ensure that the clergy and worship participants have everything they need to fully participate in the service. From distributing bulletins to setting up the sound system and marking the Gospel book, vergers oversee and manage the many parts of each worship service. The 2023 Verger Corps had ten members across the three weekly services. In addition to overseeing all of the regular services, members of the corps served at eleven memorial services.

**Liturgy Planning:** Lay Involvement in Worship Planning: *Betsy Athey, Nat White, Nadine Hathaway, Louise Walsh, Steering Committee* 

The Pilot Project for Lay Involvement in Worship Planning was conceived by a group of elders in the summer of 2022 for the purpose of expanding lay involvement in planning new, creative, inclusive and diverse services as a new iteration of our "Shared Ministry" and "Radical Welcome" ethos.

In January, February and March 2023, six new and diverse services (for Epiphany and Lent) were created and produced by four lay teams, each in collaboration with clergy, preachers and our Music Director. Each lay team included a leader and 4-5 members, most of whom had no prior experience planning liturgies or services and met via Zoom. Each Sunday Bulletin offered an attached Evaluation Questionnaire. Over a hundred were returned by congregants who, overwhelmingly, 'liked' the services, offered critiques, ideas and asked for "more."

The Pilot thus became an Ongoing Project, which continued in December 2023 with 3 separate teams creating Advent 1, 2, and 3 services. Again, the new lay participation, numbering 30 lay volunteer team members in 2023, met with enthusiastic support from the questionnaires, parishioners, clergy, preachers and Music Director.

#### **Greening:**

Easter: Stephanie Deutsch, Susan Ryerson, Bridey Heing and Jason Wallis

We visited Potomac Floral Wholesale, Linden Lane, Silver Spring the week before Easter to select flowers from the massive amount available! Our aim was to spend \$350 or less as last year; instead, we spent about \$450. We were able to work Holy Saturday morning and spent much of the day.

Thanks to Susan's participation, we had access to the sacristy and its supplies/tools. We did learn several things useful to future greeners: (a) freesias tend to wilt as do hydrangeas (b) the staff needs to know the flowers will be delivered on Friday (c) the high altar is challenging (we chose cherry blossom branches and they didn't show up well; the wholesaler didn't have big branches) (d) nandina is a good filler and there is lots of it on the Hill (e) extra flowers can be used on the table by the entrance.

We came back early in the week after to take the flowers home and put the vases back in the Sacristy.

Christmas Greening was a smaller effort this year because Advent IV and Christmas Eve were the same day. Décor was minimal and led by Doris Burton, Bridey Heing, Jason Wallis, and Jason Campbell.

Bridey, Jason, and Michael Knipe hung the wreaths on the exterior doors with blue bows for Advent on the Saturday before Advent I and changed them to gold for Christmas. Mary Cooper once again installed Chrisamons on two trees, and Maureen Shea presided over the set-up of the crèche, created by Betty Foster. The Advent wreath, a gift from Scilla Adams in the 1980s, was located next to the creche instead of over the altar. There is conversation re: its location for 2024 as its liturgical significance gets lost when it's off center.

The pageant was, once again, 'live' and held at 4 pm. The festival service was earlier than previously—at 9 pm preceded by 30 min of congregational caroling. The work done in 2021 on lighting was used to great effect this year: one verger on the light board and one managing the service. "Silent Night" by candlelight, was, once again, was extremely moving.

Altar Guild Susan Ryerson, Doris Burton, Co-Sacristans. We continue to work as singles instead of our former pairs. Guild members may choose to have a partner. Most of the brass has now been repaired and re-lacquered. The 19<sup>th</sup> C floor candelabra was the last to be done by Brass ArtCrafts of Annapolis which closed in August (a few smaller pieces, not used very often, remain to be polished). The Endowment Board approved up to \$3600 to repair and polish the floor candelabra but the actual cost ended up at \$4780 since they needed more repair than first thought. We will be creating rules for their use by parishioners and renters to reduce damage. We now use a company located in Kensington for repairs and polishing.

We are working on a design for new green paraments as ours are faded and worn. When in England, Nov '23, Doris met with Jacquie Binns (banner designer) and initial designs were discussed. We will likely need financial support from the Endowment for this project but the hangings, which usually last for 30+ years, should be supported.

The purple stoles for Lent were repaired by Susan Ryerson as some of the original tassels were lost so were replaced with fringe.

This year for Lent, we replaced all the silver and brass with pottery and wood for a simpler approach to Lent.

Our newest find is related to the only surviving frontal for the high altar. Thanks to Kenn Allen's weekly 'history notes', we learned this is part of a set of hangings dedicated in 1951 in memory of Mrs. Mulloy, a former AG president. A memorial gift of \$1000 was to be used for new white hangings but they were repaired so the court allowed the Guild to use the gift for a new green set (Pentecost). While we no longer use most of this set (with the installation of the center altar), a photo of it with the Trusheim sisters and this new information will soon hang in the sacristy.

The Guild held its annual luncheon and meeting in June. New members are welcome and train by following current members until comfortable to work alone.

Acolytes Doris Burton, Coordinator We now have an active corps of 13 members for both morning services. Five new acolytes were formally installed on March 5. An additional responsibility for them was added by Deacon Thom Sinclair at a training session in January. For Lent, acolytes wore wood crosses and only the Meade-Mahany processional cross (wood) was used. We are in the process of having the brass Ethiopian processional cross converted into a new center/hanging cross. This cross was seldom used by acolytes as it is extremely heavy. We look forward to this liturgical addition.

New volunteers age 8 and above are welcome to contact the coordinator as the next training will be in the spring.

**Chalice Bearers:** Wine has been offered since Lent I but there has been no plan to add parishioners as we have a seminarian, a deacon, and a deacon in training who serve. Vergers step in when additional assistance is needed.

**Readers' Guild** Maureen Shea (9am), Andrew Stafford (11:15) The guild is open to all. Maureen reports 21 readers for the 9. There are currently 18 readers in the rotation for the 11:15am service, with several others taking a few months off. New volunteers are welcome to contact the coordinator(s).

**Livestream operation** *David Deutsch (reporter)* continues its smooth operation, providing a wide variety of opportunities for those people off-site to see the 10 am sermon and the 11:15 service, as well as funerals and town hall meetings. The National Vigil for All Victims of Gun Violence was the highlight of

2023 as it was the year before.

We continue to recruit and train new video directors. We were sorry to lose Elizabeth Godec from the team but thrilled that she is off to college. Charlie Rupp, David Deutsch, Elin Whitney-Smith, Chris Berendes, and Matt Dodge have been joined by Victor Creef-Meza, who has completed his training. Justine Kalas Reeves has recently started training with Matt, and we expect her to be a full member of the team later this year. Chris has also started some training with Matt on the tech director role. We livestreamed nine memorial services in 2023 and find that this is often very meaningful for friends and loved ones unable to attend in person.

**CHRISTIAN EDUCATION** Karen Falk, Keith Krueger, and Greg Niblett, *Co-Directors* 2022-23; Greg Niblett and Annabelle Swift, *Co-Directors* 2023-24

**Introduction: Return. Reexamine. Reconnect. Renew.** With a more normal post-COVID return to activities, our program mounted a successful roster of classes, virtually and in-person.

One big change for the second half of the year and going of the staff. Christian Ed implemented Sunday School during January through May 2023 months of this report period. Starting September 2023 and for the future, Sunday School has been and will be administered by Youth and Family Ministries. Sunday School will now be under the YFM report.

In addition to in-person offerings, many classes met by Zoom. Video/virtual meetings are proving to be a positive addition to the mix of our programming. We expect virtual technology will allow us to have a robust CE program as some classes opt for video conferencing, some for in-person, and some for hybrid (video conferencing and in-person) gatherings.

As of this time, we feel we have advanced the process of returning to our community, re-examining our lives, reconnecting with each other, and also beginning the process of renewing our spirits.

**Program Category Summary** The Christian Education (CE) program is divided into the following categories of adult education offerings:

- Issues-Based Experiential Classes (Specific to year)
- Discussion classes/groups that intersect with St. Mark's life, mission and values (specific to year)
- Bible studies and religious classes (annually)
- Meditation & Centering Prayer (annually)
- Exploring the arts (specific to year)
- Pop-up classes (classes that spontaneously arise throughout the year after the publication of the CE Catalog)

Christian Education Philosophy Our program seeks to offer pathways to investigate, reflect on, and deepen our spiritual lives and to aid in the search for meaning. There are many types of educational offerings and we are open to and encourage any suggestions emerging from the particular interests and experiences of our parishioners. Primarily, our program strives to be a "big umbrella" program that includes various types of offerings and instructional methodologies that appeal to the different interests of parish members. A key cornerstone of the program is to create community. By taking classes, exploring the deeper issues of our lives, and engaging in discussions, parishioners have the opportunity to develop a sense of belonging and form life-long relationships with other parishioners.

#### Issues Based Experiential Classes (February 1, 2023 – March 1, 2024)

Belonging Held in May; especially designed for newcomers as they consider us for their church home but is open to all parishioners interested in building community or meeting other parishioners.

<u>The Dream of God:</u> What it Really Means to Follow Jesus: The Dream of God, written in 1991, is one of the most important books written by member Dr. Verna Dozier. It explores her challenge to follow Jesus not merely worship him, reflecting on the institutionalism bred within the church that sometimes diverts us from the true mission of Jesus.

*UBASUTE: The Journey of Letting Go:* This five-week class used expressive writing as a therapeutic approach to explore the journey of letting go of things, people, personal myths, and behaviors that are no longer useful to us, using the metaphor of Ubasute.

Stones: A Spiritual Journey Using Expressive Writing: This class explored going on a spiritual journey using stones as symbols to represent different aspects of our life. This class explored choosing and being chosen; your sense of how you were and are formed; facing brokenness; laying down your burden; making the common in our lives beautiful; etc.

The Meaning and Making of Community: What is it, where is it, and why do we need It? # FUNDED PROGRAMS FROM THE ANNUAL BUDGET (TOTAL PER ENTITY IN PARENTHESES)

#### Food Insecurity (\$4000)

- **Salvation Army Grate Patrol** (\$2000): This program brings an evening meal to homeless neighbors 365 nights a year and serves more than 3,000 people each month. Volunteers, primarily parents and children, make sandwiches and bag meals on the 4th Sunday of every month.
- **Food Justice DMV** (\$2000) Food Justice DMV is a volunteer collective delivering food and standing in solidarity with thousands of immigrant neighbors.

**Gun Violence Prevention** *The National Vigil for All Victims of Gun Violence (\$850).* December 6<sup>th</sup>, we hosted the Newtown Action Alliance Foundation's 11<sup>th</sup> annual National Vigil for All Victims of Gun Violence. Over 400 gun violence prevention advocates and survivors of gun violence attended the vigil along with special guests Second Gentleman Doug Emhoff and the ADAMS Beat Children's Choir. For the first time, before the vigil there was an all-day special program for survivors. Our staff and volunteers worked diligently to ensure that the 150 participants were warmly welcomed, well fed, and had the support they needed as they reflected on their losses.

Incarceration Justice (\$2500) We are parishioners and friends who meet to discuss and support reform of the prison systems. In 2023, our numbers grew from forty-seven to over eighty people. Since January, our meetings have included over 130 attendees, using both online Zoom access and reintroduced in-person gatherings. More than 170 individuals have received support over the year. We write "pen pal" letters to prisoners, provide books, food donations, children's clothing and toys, school supplies, and other critical help, via donations to families of Incarcerated individuals. We provided money to seventeen inmate commissary accounts. Of note, a few of the inmates who desperately needed this help were those without family or support systems. One transgender individual was afraid to enter the dining hall and relied on food from the commissary. We provided five hundred communion elements to DC jail, made numerous contributions to Returning Citizens Assistance Network

(RCAN), and volunteered at the Books to Prisoners program.

**Mission Statement:** We believe, as part of a faith community, that God's love extends to all, including people who are incarcerated and those returning to the community. We strive to educate ourselves and others about incarceration justice, promote an expectation of care, dignity and respect for all, and partner with other organizations to advocate for change, while participating in direct service opportunities. We welcomed speakers and participated in efforts, including the following:

Graham McLaughlin, who was running for DC Council. He outlined work done in partnership with other business leaders, to purchase three transitional houses in River Terrace, to house men coming out of prison.

Sonya Crudup, Vocational Development Specialist, from the DC Department of Human Services Ready Center.

We joined our new member, Jeremy Sierra – in support of the Steps Towards Justice Walk-a-Thon on May 20th, to support Advancing Real Change [ARC]. Their work toward a more just and humane criminal legal system - focuses on helping people facing extreme sentences, such as the death penalty and life without parole.

We attended a presentation by Anthony Ray Hinton, sponsored by the New York Avenue Presbyterian Church (NYAPC) McClendon Scholar-In-Residence Program. Mr. Hinton talked about his experience as a man convicted of a crime he did not commit, life on Death Row, and the extraordinary gift of working with Bryan Stevenson. He shared vignettes from his book, <u>The Sun Does Shine</u>.

September: we sponsored an in-person meeting, to include stories and poetry reading with <u>Free Minds Ambassadors</u>

October: we screened a documentary film, "Redemption", and welcomed Council member Charles Allen to a discussion of Public Safety (in-person and online participants)

December: we gathered again, to write to residents of the DC Jail. We sent over twenty letters and over thirty children's drawings, in two large batches. This was an intergenerational activity offered after all three services for two Sundays.

We are thankful for support from the Service and Social Justice Board which enabled us to donate to Free Minds, the DC Jail, and RCAN, associated with NYAPC. Contact Jan Lipscomb: incarcerationjustice@stmarks.net

#### **International Programs**

Sustainable Villages Honduras (\$2000): The Outreach Committee has supported the non-profit Sustainable Villages Honduras (SVH) since its launch April 2017 and dozens of individual parishioners have also been very generous. 2023 was a particularly successful year for SVH. March 2023, six people from the SVH Board, including two from St. Mark's, paid their annual visit to Santa Barbara, Honduras. They participated in a celebration of the Honduran government declaration of the El Zapotal watershed, which supplies water to seven villages in the Chinda Municipality. SVH has supported the village water management teams preparing for this declaration and funded the watershed expert who led the effort. The SVH board team participated with Coordinator Roy Lara launching SVH work in five additional villages in the municipality of Trinidad. March 2023, no farmers in any of these villages used organic agriculture and their soil was losing fertility. No villages had health committees or effective water management boards. By the time Roy Lara visited St. Mark's fall 2023, many farmers had adopted organic techniques and were engaged in testing seeds for resistance to drought. All villages had formed active health teams and were working with the municipal health center to vaccinate families and treat tropical illnesses. Roy Lara presented the SVH story to 51 people at St. Mark's, in private homes, by zoom. and at ECO-city farms, a non-profit in suburban Maryland that trains farmers and supports incubator farms.

**Mid-East Working Group** – This group chose to phase out at the end of 2023. When MEWG began in 2009 there was a real vacuum in Washington in re: any kind of full understanding of the situation in Palestine and Israel. Through MEWG, St. Mark's accepted the challenge of changing that in a multitude of ways – panels, movies, pilgrimages, newsletters, and hosting speakers. Over time, that vacuum

has been richly filled by several organizations with both more resources and greater outreach than St. Mark's. Recognizing that, as well as the decreased in interest at St. Mark's, the committee asked leadership to allow MEWG to dissolve itself and they agreed. Michele wrote: "It is a rare opportunity to end well in the life of a church. I so appreciate your willingness to discern and to decide." With the tragedy now unfolding in Palestine and Israel, there may well be a time when a new committee with a new vision will form.

# Migrants and Refugees (\$2500)

**Refugees and Humanitarian Parolees (\$2500):** Thanks to the Social Justice budget and our Temporary Restricted Fund for Afghan Refugees as well as contributions from Washington Community Fellowship, we were able to help our families with rent, ESL; and computer classes, as well as purchasing a computer and needed food and clothing items. We continue to work with Christ Church+Washington Parish as well as the Diocesan Refugee and Migrant Committee.

With the help of Good Neighbors Capitol Hill, Latifa Haidari and Barkat Azizi have moved to a more affordable apartment near Congressional Cemetery. This has enabled them to keep their jobs at Eastern Market/Trader Joe's and to continue their ESL classes. With Lucy Brown's guidance, we and the Washington Community Fellowship purchased a much-needed new computer for Barkat's IT classes. Yusef Stanikzai celebrated his fifth birthday with friends at Burnt Hill Elementary kindergarten. His mother and her friends are continuing their ESL classes with Andrea Harles of CC+WP. Michael Crawford from CC+WP is tutoring the Tokhi's 8<sup>th</sup> grade son. The first family we assisted back in 2017 are still struggling to adjust to life here. Karen Getman is working with fellow Episcopalians close to where they now live to provide support as needed to resolve some of the issues. Afghan refugees continue to arrive in the DMV and we continue to discern how to help newcomers while supporting the families already settled.

St. Mark's Partnership in Good Neighbors Capitol Hill: As a founding member of Good Neighbors Capitol Hill, our Board continues to contribute funds to the work of GNCH and members of our community donate and volunteer to support this refugee ministry. The 8 member congregations and many unaffiliated volunteers and donors maintain the primary vision of GNCH by creating a welcoming home for new arrivals. The GNCH coalition of congregations (in partnership with Lutheran Social Services) collects and furnishes apartments (assigned by LSS) with new and GIK donations from neighbors and friends. As a member of the leadership team, we provide annual funding to the work of GNCH and takes full responsibility for supplying the bedding and bath linens as well as toiletries for the newly arriving families. Other congregations take responsibility for the various supplies needed. January 2024, GNCH completed their 122<sup>nd</sup> apartment with furniture, bedding and bath linens, toiletries, backpacks with school supplies and toys, as well as 1 month food provision for each refugee family (principally in Prince George's County). GNCH is committed to continue this effort of preparing well-furnished apartments for the many more refugee and asylum families who arrive in the DMV area. Donations of gently used furnishings, appliances, TV's, bed and bath linens and kitchen supplies are welcome. The web-site GoodNeighborsCapitolHill.org provides an overview and contact for donations or volunteers.

**Migrants Bused to DC** – Since Spring 2022, the governors of several border states began sending migrants to northern cities, including Washington, to protest the border crisis and the lack of immigration reform. It is estimated that as many as 11,000+ migrants have been dropped off in DC with some of those individuals electing to stay in this area.

We have responded by sending volunteers to respite and welcome centers and by being the supplier of new underwear, shoes and socks for men, women, and children frequenting the free store at a partner church on Capitol Hill.

# **Responsive Grant Program (\$900)**

In 2023, the Board set aside \$900 to give parishioners the opportunity to develop outreach initiatives. Last fall, we advertised in-house, the chance to receive a small grant to jumps-sart or assist a new project (not already funded by the church) to benefit the larger community outside our walls.

This year, we received one proposal (Global Co Lab Network) which the Board funded. The Co Lab was

founded in 2014 by parishioner, Linda Staheli, who volunteers as Founding Director and manages the Arlington-based non-profit based in Arlington VA. The Co Lab empowers teens locally and globally to connect, collaborate, learn, and act on the 17 United Nations Sustainable Development Goals (SDGs).

The Co Lab sponsors an annual global video challenge (now in its 10th year) and 12 virtual weekly SDG hubs led by teens working with adult mentors, interns, advisors, and partner organizations. Teens globally lead and work collaboratively with other teens who share a passion for learning and taking action on significant issues of our day, focusing on climate change, mental health, hunger, gender equality, racial justice, wildlife conservation, quality education, and plastic pollution, as well as dedicated hubs that engage teens in Spanish, Turkish and Persian/Dari. The Co Lab currently has teens participating from the USA, Mexico, Colombia, Spain, India, Nigeria, Cameroon, Turkey, and more. The SDG hubs are an impactful way for teens to connect with other teens from different parts of the world while learning and growing together and making the world a better place.

A few highlights of the teens' work include:

- Racial Justice Hub presented an Implicit Bias workshop to the Director of Diversity, Equity and Inclusion for Arlington Public Schools and to fellow Co Lab members.
- 2022, 20+ teens traveled to DC in July to attend the Smithsonian Folk Life Festival where they spoke on 10+ panels.
- 2023, the Co Lab took 9 teens from the US and Mexico to the United Nation's High Level Political Forum. They spent a week learning about the UN, speaking at numerous official meetings, presenting 3 side events, and finishing filming of the Co Lab's soon to be released documentary by teens and for teens. The film will debut at the Ocean Institute in California, and other showings are scheduled elsewhere in the US and abroad.
- Videos, podcasts, published books and more can be seen on the Global Co lab website, https://www.globalcolab.net.

A few of our adults and teens helped Linda Staheli found the Co Lab's Teens Dream video challenge, and a number of others have participated in the Co Lab's programs, served as mentors, been on the Board, and more. Linda and others are working to involve more of our teens and adults in this inspiring work.

Depending on SSJ Board funding, we hope to offer a similar grant program in 2024.

# Social Services/Homelessness/Social Justice (\$16,363)

**Everyone Home DC (formerly Capitol Hill Group Ministry) (\$12,363)** established in 1967, helps neighbors, especially families, who are homeless or at risk of becoming so, with achieving housing stability and maximum self-sufficiency. EH-DC operates several neighborhood-serving programs.

Last year, they continued to assist thousands of individuals experiencing homelessness to meet their basic needs and supported hundreds of families in avoiding or transitioning out of homelessness. Our members were instrumental in building one of these programs, Shirley's Place, in response to the need for people experiencing homelessness to spend their day off the street. It provides a safe and comfortable place they can go for a meal, take a shower, do laundry, and talk with counselors. In 2023, Shirley's Place provided more than 1800 individuals with nearly 6,000 meals.

Our longstanding partnership continues with former Senior Warden Ryan Baugh serving on the Everyone Home DC board where he has a major leadership role as chair of its Governance Committee.

In addition to our corporate financial support, parishioners supported EH-DC drives for school supplies, Thanksgiving dinners, and holiday gifts. In '23, more than 20 donors gave \$2500 to these drives, supporting 42 families. (Note the process developed during the pandemic of giving supported families shopping cards in lieu of donated goods has empowered them to provide for their families. We expect this process to continue.) Parishioners had the option of donating online or mailing a check to EH-DC. Our parishioners made additional personal donations and supported the fundraising auction.

**Samaritan Ministry of Greater Washington** (SMGW) (\$1,000 in 2023; \$2,500 proposed for 2024 (<a href="https://samaritanministry.org/">https://samaritanministry.org/</a>) We were one of 12 Episcopal churches that founded this group in 1986. The organization helps individuals across the metro area — including many returning citizens — improve their lives by setting realistic goals in education, employment, housing, and health. Caseworkers and trainers, together with volunteers, then assist program participants in defining and taking the "next steps" they need to achieve their goals. In 2023, SMGW served 3,338 individuals, as-

sisting many with immediate needs while working long-term with 765 who committed to participating

in its Next Step program.

Today SMGW's Partner Council consists of 50 Episcopal churches plus the Cathedral, diocese, two Episcopal schools, and four churches of other denominations. In 2023, the Ministry served people at offices located in Anacostia, Congress Heights, Northwest DC, Arlington, and Silver Spring. (The latter office is temporarily closed till a new Spanish-speaking caseworker is hired). It also provided job readiness and IT training at two affiliated locations: the Skyland Workforce Center in Southeast and Byte Back on N. Capitol Street. In 2024, the Ministry will open an office at St. Paul's Rock Creek to serve people in NE/NW DC and adjacent MD suburbs. In 2023, Mary Neznek and Peter Hawley served as our representatives to the Ministry's Partner Council. In addition, 15 parishioners attended the Ministry's "Next Step Breakfast" event at the National Press Club in March while others attended the Gala in November, donated theme baskets for its silent auction or items for the live auction, or donated children's books and gift cards for the families of those enrolled in the Ministry's Next Step Program.

Washington Interfaith Network (WIN) (\$4000) Core team: Kit Arrington, Edna Boone, Josie Jordan We maintained our active WIN member role through financial membership and by parishioner participation in WIN actions and initiatives. 68 parishioners are now members. WIN's major areas of impact in 2023 and our engagement include:

- Affordable & Public Housing: Organized and hosted a WIN film and discussion with the creators of the film Barry Farms, attended by 133 in-person and online, a local story that illustrates the injustice and community disruption of displacement. Through relationship with the residents of the Potomac Gardens Senior Housing public housing building, we supported their self-advocacy with DCHA addressing over-due maintenance and organizing with other public housing advocacy organizations for resident rights awareness during renovations, resulting in a model MOU submitted to DCHA in October. We participated with WIN Ward 3 to demand developers and the city provide affordable housing developments at the Chevy Chase Library and other locations in NW.
- Climate: Supported the Healthy Home Act, i.e. legislation to help 30,000 low-income residents improve energy efficiency and make their homes safer. Through WIN's Climate-in-the-pulpit we offered issue education with our households participating in data gathering in-home (and in our kitchen with families and interested parties) emissions tests, also providing a community organizing learning opportunity for Seminarian Joel Martinez. We organized and sent ~40 parishioner postcards in support of the Act.
- Public Safety: Inaugurated WIN's comments on the city's budget with Councilmember Actions
  bringing together ~100 folk (26 from St. Mark's!) with Ward 6 Councilmember, Charles Allen, obtaining commitments for his support of WIN's Black Equity Through Homeownership (BETH) initiatives, DCHA accountability for safe and secure Public Housing, implementation of Climate change
  actions, and also providing WIN's support for his Criminal Justice Reform Bill including WIN members in the audience during the Congressional hearing.

We participated as event organizers, volunteers on actions and ongoing initiatives, door knocking/listening sessions, educational opportunities offered, and attendance at Councilmember events for Wards 3, 6, 7, culminating in over 200 people gathering in Metropolitan AME for a Public Safety Action with Ward 2 Councilmember Brooke Pinto, chair of the Judiciary Committee (10 from St. Mark's.) We hope to continue seeking opportunities for overlap and partnership with related efforts at St. Mark's (e.g., WIN promotion of the Incarceration Justice movie showing, "Redemption", and promotion and participation in the book group on Economic Inequality.)

# **Youth Development**

**Bishop Walker School (BWS)** (\$4000): This school for boys is a tuition-free Episcopal school for children from traditionally underserved communities. We have regularly supported it with financial donations and continue exploring other means of supporting their work. Among BWS' highlights for 2023 was the installation of Dr. Angelina Arrington as new head of school on October 13. See https://www.bishopwalkerschool.org/ for more information about BWS.

**Vision 2020 Excess Capital Funds**\_In addition to distributing the funds from the operating budget, in 2021-2, the Vestry charged the Board with disbursing \$15,692.76 in monies leftover from the capital campaign to worthy charitable organizations and initiatives. The Board voted to fund the following ongoing work:

<u>Navajoland</u> - February 22, 2022, the Vestry designated a proposed partnership between St. Mark's and St. Christopher Missions Church, Navajoland, as a recipient of surplus funding from the Extended Vision 2020 campaign.

In its second year, this initiative focused on organizing its first youth trip, with five high-schoolers visiting Navajoland for a week in July, under the supervision of Youth and Family Minister Caleb Nelson Amaker, Kit Arrington, Charlie Rupp, and Mary Neznek. The focus of the week's activities was an exploration of significant historical, cultural and geographic elements of the local region. It also included a series of conversations with local residents and others about Navajo history and culture and the environmental, economic, and social challenges facing their communities, as well as the sources of resiliency and hope for the future. After, the pilgrims reported to the congregation in a standing-room-only pub lunch presentation.

The Navajoland Initiative Steering Group is now developing plans for a '24 visit by Navajo youth to DC and a second online book group connecting parishioners from St. Mark's and St. Christopher's. WIN is self-financing; we study hard and have fun as we continue to swerve and bounce with the market. We welcome new members.

Archives & Parish History Kenn Allen, Doris Burton, Mary Cooper, Bridey Heing

2023 was a year of significant work and accomplishment for the team. We are deeply grateful to the board of directors of the Endowment for their ongoing support, most recently through the \$15,000 grant that supported our work in '22 and '23 including preservation and digitization of a number of our most important parish records. Without that support, our work would not have been possible. In 2023, we:

- Arranged for the restoration and digitizing of parish records dating from 1893 to the 1970s baptisms, confirmations, deaths and records of Sunday services.
- Researched, designed, produced and installed an exhibit on the Rectors since our founding, including biographical information and photos. To be permanently hung in the Rectors Room.
- Researched, designed, produced and installed a major exhibit on the life and work of our 9<sup>th</sup> Rector, The Rev. William Baxter, rightly credited with saving St. Mark's from likely closure and destruction in the 1950s and 1960s. He introduced Functional Christian Education, integrated the church, developed Chancel Drama, encouraged creation of the Dance Studio and led the congregation into greater engagement with the challenges of the neighborhood. The exhibit recognized the centenary of his birth, October 5, 1924 and included a panel discussion of parishioners who here during the Baxter years.
- Published in the weekly Gospel, "This Sunday at St. Mark's" articles drawing on our collection of church bulletins that date back to the late 1940s.
- Made significant progress on the ongoing organization of the Archives including support for the
  work of Karen Falk and Louise Walsh on the Christian Education archives and initial steps in indexing the records of the Endowment. We began a trial run of digitizing Vestry minutes.

Lichfield Link While our friendship link with this English Cathedral was not very active for a number of years, Doris Burton, our link rep, continued a correspondence with Pat & Brian Empsall of Lichfield. With the news that the choir will be going to England in 2025, Doris traveled to the UK in November to renew the relationship, met the Interim Dean, saw a number of friends from past visits, and experienced Remembrance Day, so different from the US and exceptionally moving. In January, she presented a Mission Moment to educated new parishioners about the history of the link. Then, in March, a friend of the choir from the '96 visit, The Very Rev. Charles Taylor, former Canon Precentor, died after a long illness.

Hospitality Maureen Shea and Kenn Allen; Coffee hour/accompanying snacks continue to provide an important time for community building, particularly after Sermon Seminar. Often there are youth and Social Service and Justice projects simultaneously in Baxter Hall. They may increase consumption of food and drink but add a good sense of the ways people are engaged at St. Mark's. Attendance, however, is small after the 11:15 service. Budgeted funds purchase coffee and snacks, and there are donations of snacks from the Sunday school teachers. Challenges remain recruiting people to serve and clean up, especially after the 11:15. Contact Maureen or Kenn to volunteer

Saints and Sinners Harvest Celebration Janet & Don Lipscomb, Karen Woodall, Jim Brooks, Jason Wallis, Bridey Heing, Kit Arrington, Karen Weidemann, Shay Waye, Leslie Allen, Doug Ammon, Lisa Ramish. We used the nave and Baxter Hall as opposed to 2022 when we had to make back-up plans because of Covid. We welcomed eighty adults and twenty-eight children and another dozen or so walk-ins. Acrobat, Ashley Rivera danced with multiple lighted hula hoops. We had face-painting, photo opportunities amongst balloons and the Barbie box, coloring a mural, plus additional children's activities hosted by Deborah Cunningham and her team and our Deacon Intern, Annemarie Quigley. Each child was given a personalized photo after the costume parade. Shay Waye was a shopper extraordinaire, and managed most of the catering while others brought food and beverages to share. Karen Weideman made numerous trays of "scary looking" and tasty Halloween cookies! We danced and enjoyed being together with revelers of all ages!





#### **STAFF REPORTS**

The crozier of the 6thC pope who sent Augustine to England to begin the conversion of the Anglo-Saxons

Rector The Rev. Michele Morgan

Let me start with what I put in the overview promotional report for guests:

**Numbers:** An important statistic for all churches is tracking weekly attendance and how it shifts over time. Here is where we stand for 2023 compared to past years, through the last Sunday of the year: **12/31/23.** We have had a total in-person attendance for our three services of **10,551.** To understand the impact of COVID-19 on the parish, between 2007 and 2019 our annual attendance was 14,916. In 2019, it was 14,753. As you see, we are down about 5000 per year.

One example of growth: Support for our music program has brought additional vitality to St. Mark's. By supporting the music director, our choir is growing -- with 20-30 year olds! Funds for a tenor section leader enabled the choir to sing more challenging pieces and support one another. Jeff put money into challenging and beautiful musical works. We made space in our calendar for concert performances generating revenue and bringing in more people some of whom have joined the church and the music program. The music fits within their interest and in such a transient community as DC, allows them to make connections based on mutual interests. Through that connection, the choir has become a community with members showing up for one another and serving as a model for other groups in our congregation.

Continuing to invite people For the past eight years, we have offered a class called 'Belongings'. I want to start moving people along, not just give them an idea of *belonging* but also to give them a chance to *believe* and to answer the question of how that might help us *behave*. Our goal this year is to use our already existing *Belongings* class to create more access to teaching about *believing* using our worship planning and how we worship along with other adult classes. The last side of this triangle is how we *behave*, using the lens of social justice, service projects, sermon seminars, and the ways that that move us towards discipleship, forgiveness, and the desire to invite more good things into our lives. We will continue to look for reinvigorated ways to live into the 'why' of our fellowship, discipleship, and service. The ultimate goal is to invite people not just because we are a great place to come, worship, and have fellowship, but because our goal is to live into belonging, believing, and behaving.

Now to the nitty and the gritty:

- Annual Meeting 2023 the following four by-law amendments were proposed and adopted:
  - 1. The annual meeting can be held between January 1- March 31
  - 2. Allow virtual or hybrid parish meetings.
  - 3. Changes the title "register" to "clerk" (for greater transparency and consistency with Episcopal Church/diocesan terminology).
  - 4. By-Laws can be amended at special parish meetings
- **Stewardship in 2023** In 2023 our goal for pledges from our congregation was \$863,000.00. We ended the year with \$886,343.03, \$23,343.03 over our low-end goal.
- Personnel I continue to be grateful for Michael Gravlee, Annick Milde, Caleb Nelson Amaker and Jeff Kempskie.
- Deacon Thom Sinclair is overseeing Annemarie Quigley who will be finishing her deaconate internship June 2nd.
- The Personnel Committee is now functioning and working with me to complete reviews to help the staff know what they are doing well and where they can improve.

#### **Seminarians**

Our own Caitlin Frazier was ordained to the Transitional Deaconate

**Chris Leung** was to join us but her bishop felt St. Mark's was not a good fit.

**Lydia Arnts** transferred from Colgate Divinity in Rochester, NY, to Virginia Theological Seminary. Her Bishop decided we are a great fit, that Lydia is learning a lot, and gave permission for her to remain for a second year.

**Worship** We continue to seek a worship chair and are grateful to Doris Burton for continuing to step in. Ash Wednesday was February 14 and the clergy came through with an Ash Wednesday extravaganza. We held the traditional 7 am, 12pm, and 7 pm services as well as being at Capitol South Metro with Ashes-To-Go during the morning rush (8 am to 9:30) and the evening rush (4:30 to 6:30 pm). About 150 people attended the services at St. Mark's and we distributed ashes to 200+ people at the Metro. We are now busy preparing for Holy Week. We moved "Following after Jesus" to the start of the week. It is not my favorite thing to do yet we are trying to deal with the realities of the local school systems spring break. The goal is to do it on Holy Saturday, having the CHILDREN 'find Jesus' for the first Eucharist of Easter, their delight in having the alleluias back, and recapping Holy Week rather than forecasting it. Pilot project for worship planning: What worked: the ownership and enthusiasm the various teams had about each service, new prayers and contexts, inviting others to attend church (in general), groups didn't add things to try to connect materials. There was a clear focus for most themes, involvement of different (and some new) people in liturgy planning, using gray boxes in the bulletins as descriptors, creative hymn singing (having a soloist walking to the center to invite others to join), careful consideration to selecting hymns that reflect the desired theme, and creating more opportunities for contemplation or meditation. Advent 2023 invited people in, was well organized, and I am grateful to all those who worked on the project.

**Pastoral Care** I want to thank Patricia Catalano for her work caring for people who are shut-in and unable to be physically present at church. Between the two of us, we keep a close eye on 15 people. Deaths this year: 14 longtime members died this past year. Folks we saw regularly: Jan Hoffman, Linell Grundman (Senior Warden), Bertha Martin (Altar Guild Chair Emerita), Margaret Wood, Fairfield Butt, and those who moved away or whose health considerations kept them away; John Lineberger, Wes Foster, Mary Welker, Dail Doucette, Joan Perotti, Nancy St. Germaine, Paul Mahaney, Beryl Lilliston Maloney, and William Flanders. It has been a difficult year and I hope that everyone is on this list and the memory of them will continue to be a blessing.

*Christian Education* continues under of the leadership of Greg and Annabelle. I continue to be grateful to them both.

**Service and Social** Justice Edna Boone and Holly Kreutter have agreed to become co-chairs in the new year.

**Arts** Elin and JR continue to bring art to the forefront and it is exciting.

**Parish Life** Unfortunately, Karen Woodall decided to step down from the Chair position. We are looking for someone to take over. I am grateful to Karen for her time and energy

#### Satellite organizations

St. Mark's Players We had success leaving the risers up on Sundays and will continue to look for ways to benefit us both. The Players are celebrating their 40th year and looking for ways to connect with the parish. They are in contact with the Archives Committee and the Arts pillar to assist in celebrating this anniversary. They contribute \$1000.00 per show to our operating budget and the board hopes to raise that amount. I believe they are considering \$2000.00 per show or \$6000 a program cycle. We may expect between \$1000-\$2000 per show next season.

Dance Studio Dorothy 'Dot' Walker is the new artistic director and Rosie Brooks has become the *director emerita*. The board has reformed and meets regularly. I am grateful to those who have made that possible.

*Music Studio* Continues providing lessons and a percentage of the income goes into our operating budget.

Meditation Group meets regularly and Michelle Rivard, coordinator, does an excellent job of holding space and creating interesting programs. The group donates \$1000 to our operating budget.

Yoga Studio contributes \$600 twice a year, for a total of \$1200 this year.

Finally, thanks to Vestry members/officers Shay Waye, Randy Marks, Bill Jordan, Chris Berendes, Jeb Ory, Katherine Buchanan, Martha Huizenga, and all those who made 2023 a wonderful year of growth, community, and Joy.

Personal Note Thank you for taking the time to read this report. Earlier this year I had a tough month: my new- to-me dog, Trixie, bringer of joy, had a medical crisis and died in my arms. Michelle Dibblee, my spouse, continues her education in New York City, bouncing back and forth; then, I was asked to fill the remainder of the term for the representative of DC Southern Region on Diocesan Council (we meet the second Tuesday of the month). In January, I was elected to a three-year term on my own. I am especially grateful that my knee surgery was successful: I continue with PT and look forward to the day I can, once again, ride my bike to St. Mark's.

#### ADJUNCT/PASTORAL ASSOCIATE The Rev. Patricia Catalano

It continues to be a privilege for me to work with the people of St. Mark's. I have been serving the parish since May 2018. A significant part of my work now is as Pastoral Associate, a non-stipendiary position. In 2023, I served in a variety of roles, including priest, spiritual guide, and pastor.

Here are ministries in which I was involved March 2023 -January 2024:

#### Liturgical role:

- Preached seven times from January 2023 to January 2024 and presided/co-presided with Michele and/or Chris the Sundays I preached.
- Co-presided with Chris at morning services and preached/presided at the 5 pm service when Michele had knee surgery
- Preached at Linell Grundman's memorial service
- Concelebrated with Michele at Elizabeth Long's memorial service
- Assisted in Grace Coogan's baptism
- Led All Souls' Day Service of Remembrance (Attendance:19)
- Preached at Fairfield Butt's memorial service

**Centering Prayer**: This faithfully continues as a strong online ministry entering its fourth year. We still meet at 8 for reading, contemplation and fellowship. March 19, 2024 will mark four years that we've been meeting on zoom. Not everyone attends every day, but members alternate in a very organic manner. The total number of days we held centering prayer in 2023 was 273 with a total attendance of 3012, and an average attendance of 12.

We have created a prayerful community of contemplatives who engage in functional theology and deep discussions on faith and other matters. Last year we read six books, as well as various articles and reflections. Over the course of yet another challenging year, our group continues to grow in faith and to support one another pastorally and spiritually as we walk in our journeys with God.

**Laying on of Hands Training** Offered two training sessions for LOOH ministers, the first one on October 7. Eleven people attended. Joining the group were some veterans who shared their experience with the new ministers. The second training took place on December 10 with six ministers in attendance.

**Grief and Loss Group** has met online every other week since June 2022. It is a ministry that helps those who have lost a loved one or are experiencing deep sorrow to go through the mourning/grieving process with others who are in a similar journey with care and compassion. Twelve people have participated since the group started.

**Pastoral Care** Michele, Chris and I share pastoral duties, which include visiting the sick and other parishioners who may be experiencing life challenges as well as meeting and keeping in touch with those who reach out to the clergy for counsel. The clergy keep each other informed of any and all pastoral matters that come our way. We also enlist the help of lay volunteers who feel called to visit and care for fellow parishioners in need.

Other Attended Diocesan Convention in January 2023

#### **Deacon** The Rev. Thom Sinclair

2023 was my first full calendar year at St. Mark's and marked 1 ½ years of being with you. Thanks be to God! I am so blessed to be assigned to such a dynamic, loving, and thoughtful community.

My role as your deacon has been focused on empowering the laity and participating in the liturgy. My goal is to emphasize the role of baptized members of the church in fulfilling their baptismal covenant.

As part of this, I've worked throughout the year with the newly re-named Service and Social Justice Board, including co-leading two retreats with former Chair, Julie Murphy. I have tried to work with them to raise up new leaders, involving them in ministry, introducing new ways of looking at our work wholistically, and working closely with those deeply involved and committed to this work.

My role in the liturgy reflects this service orientation as I fulfill my diaconal role in proclaiming the Gospel, inviting the confession, serving at the Lord's Table by preparing and placing on it the offerings of bread and wine, assisting in the ministration of the sacrament, and dismissing the congregation.

Empowering the laity in the Gospel procession has been something I've been very happy to introduce this year. We've brought the Gospel out of the pulpit and to the people. And we have now involved the laity- the acolytes- in the Gospel procession.

Deacons in most dioceses and parishes preach occasionally, but I have been fortunate to be in a parish that has allowed me to preach 7 times in this past year. That is truly amazing given the caliber of preaching that is both expected and found at St. Mark's.

This has been a wonderful year, and I can't neglect to mention the highlight of 2023- having Annemarie Quigley as our deacon intern. St. Mark's has been blessed to have her, and it has been a joy for me to be able to mentor her in her parish internship work.

I want to thank the parishioners of St. Mark's for their continued support and welcome to me and my husband Jim. We are happy to be among you!

#### **DIRECTOR OF MUSIC** Jeff Kempskie

**Chancel Choir** The choir continues to rebuild and gain momentum after a long post-pandemic recovery. The group sang for the late Senior Warden Linell Grundman's memorial service mid-February, led an evensong service with special music later that month, for former choir member Mary Welker's funeral in mid-March, two movements from Monteverdi's *Messa a 4 voci da Cappella* for Laetare Sunday (Lent 4). and prepared music for Holy Week and Easter when we were again joined by a brass quartet. The choir concluded the season with an Evensong service at the beginning of June.

Soloists and the occasional summer choir provided musical leadership June-August. In late August we said goodbye to soprano Logan Clark who moved to Cardiff, Wales, to pursue a Master's in Vocal Music Performance at the Royal Welsh College of Music & Drama. Logan made significant contributions to the music program for a number of years.

The choir began the fall season in late August and a retreat in mid-September. They led the music for a special service featuring the *Missa Gaia* (Earth Mass) with guest instrumentalists and projected images in October. The group was delighted to sing for the wedding ceremony of choir members Kristina Keenan and Luke Giannini in early November and finished the year with Advent Lessons & Carols in early December and a festive Christmas Eve service with brass. They sang for former choir member Fairfield Butt's memorial service in January and an evensong in late February. Overall, the last year has been a successful one.

**Children's Choir** Judith Rautenberg continues her third season as director. After a strong finish in the spring, the choir came back for a fun-filled retreat in late August. In the fall, we had enough children (about 25) to divide them into two groups for rehearsals: the youngest, 5 to 8 year-olds, rehearse Sundays from about 11:00-11:30 and the older 9-11 year-olds from 11:30 to 12:10. Despite inconsistent attendance at times, the choir has grown and made good progress. We are continuing to come up with more ways of building community and cohesion among both the children and parents.

**Handbell Choir** This ensemble continued its bi-monthly Wednesday rehearsals under the direction of Katherine Anderson. Sarah Headley, who co-led the group for a number of years, recently had to step down. The ensemble is currently learning new music and continually working on developing its ringing and music-reading skills while having fun in the process.

Instruments & Equipment The 1959 Holtkamp organ has, with just a few small exceptions, continued to remain in good working order. Cleaning, re-leathering, and some modifications to the swell box are currently being considered. The Yamaha grand piano remains in satisfactory condition. The Steinway C piano technically owned by the Chiarina Chamber Players has settled in and is in excellent condition. The Baxter Hall piano is tuned bi-annually and remains in fair condition. The Kohler & Campbell grand piano in the music studio - a donation from 2015 - remains in good condition. We are trying to sell it, however, with the intention of replacing it with the Yamaha grand from the nave while we have access to the Steinway C piano. The church's three digital pianos remain in satisfactory condition. The handbells are in good working order. The harpsichord was not used.

**Music Studio** In-person voice lessons continued with Diane Atherton teaching in the Elders Room one evening per week and Anh Ngyuen and Sasha Beresovsky teaching several more piano students in the Cox Music studio. In addition, Saeha Youn began teaching piano one day per week. Judith Rautenberg started teaching individual voice lessons as well as music classes for young children.

Other Music-Related Happenings We furthered our role as an important performance venue for music ensembles in the DC area. When the Library of Congress' Coolidge Auditorium suffered water damage from a pipe break last winter, their staff promptly contacted us to see if we could hold several of their previously-scheduled concerts. We were honored to host a total of seven different concerts by some of the world's top classical music ensembles including Klangforum Wien, Bach Collegium Japan, Ars Nova Copenhagen, pianist Sir Stephen Hough, the Harlem Quartet, Orpheus Chamber Orchestra, and the

Signum Quartet. These concerts brought hundreds of new faces through our doors while also generating a substantial amount of revenue. Several other highly-respected groups again performed in the nave this year: The 21st Century Consort, Folger Consort, Washington Bach Consort, Eclipse Chamber Orchestra, Chiarina Chamber Players, Armonia Nova, and The Thirteen. Groups new to us included Musicivic Baroque, Matchstick Percussion Ensemble, and the Smithsonian Chamber Orchestra. Other events included the annual "Carols & Cheer" sing-along in December and January "Sandbox" concerts for young children organized by children's choir director Judith Rautenberg.

**YOUTH AND FAMILY MINISTRIES** *Caleb Nelson Amaker, Director;* Kit Arrington, Mary Miller, Terri Nostrand, Denise Oliveira, *Leadership Team;* Meg Platt *Vestry liaison.* 

February '23 began the transition of Sunday school moving from the Christian Ed pillar. This was decided by the CE co-directors, Stephanie Deutsch (coordinator for Catechesis of the Good Shepherd), Sunday school teachers, and Rev. Morgan.

**Confirmation:** YFM also resumed its biannual class: six youths participated in ten sessions from February-April. The class was taught by the YFM Director with help from Rev. Morgan and Rev. Christopher Phillips. Upon completion of the class, all six chose to be confirmed during Bishop Mariann Budde's parish visit in April.

Youth Service Trip: Kit Arrington and Steve Dalzell from the Navajoland Steering Group, chose St. Christopher's in Bluff, UT as this year's destination. In July, five students traveled to the mission there. We worked with the Mission, an Episcopal church hub, and met with members of the community, cleaned the mission cemetery, organized food donations for distribution, visited local museums, and met several members of Navajo to learn about their life experiences. Everyone also participated in the worship, "Seeds of Change: Toward Right Relationship with Native Peoples," led by Friends Peace Teams, to begin learning about the cultural experience of Native people in the United States.

"Art in the Garden" in August, included a Navajoland trip celebration. A luncheon was given for the participants who shared stories and pictures with a room full of parishioners.

Kit Arrington organized the trip with Charlie Rupp and Mary Neznek of the Steering Group as chaperones.

**Parents Night Out:** Our two semiannual events were held in March (20 attendees) and November (17 attendees).

**Legos Project:** We held our first "Lego Stations of the Cross" event in which each participant created a Lego representation of one of the stations. Led by Loretta Veney and Terri Nostrand over two weeks, the finished stations were displayed for three weeks in the chapel, beginning Palm Sunday.

**April:** "Walking After Jesus," our dramatic retelling of Holy Week for children was held with six families and several adults. Easter Sunday we had two Easter Egg hunts: 450 eggs were hidden, 400 donated by the congregation.

May: We began planning for fall by recruiting new leadership team members. The team planned summer events: three sessions of "Art in the Garden", our monthly summer arts and crafts program that encourages families to gather to make art and enjoy fellowship. The first was in June. We also held a parent's meeting to grow excitement for the coming program year

**September:** Our kickoff was the parish barbecue. Final programming duties for Sunday school began with a blessing of Sunday school teachers on the first day of classes. In addition to the three Catechesis classes, youth classes were separated into middle and high school classes, with their own curricula. 31 students were registered for Sunday school and three middle/high school events were added to the calendar.

**Advent/Christmas:** Advent wreath decorating was held in late November. The pageant, on Christmas Eve, included about 20 families and focused on roles allowing the congregation to participate in the narration. Meg Platt, Laura Gladstone and Holly Burkhalter organized costume distribution and rehearsal.

**Ski Trip:** This returned for the first time since the Covid lockdown. 31 children and adults participated in a weekend of skiing and fun in Davis, WV, that included art activities, a pizza party, and a community dinner with parishioners Nora Howell and Karen Wiedemann who live/vacation in that area.

Throughout the year, YFM continued to increase communication efforts. In addition to a weekly news-letter, and family Bible study questions, we updated the congregation on our renovation process through reports in the Youth E-News and the E-Gospel. Our Bible 'Storytime Podcast' sent out six episodes weekly to families. We continue to connect with families offline by mailing invitations to big events and sending our students birthday cards.

Thank you to all who volunteered with our events this year. We are looking forward to the next!



### **LEGACY LIONS 2023**

We launched the Legacy Lions in 2017 as our planned giving program to recognize those parishioners who have made commitments to St Mark's in their estate planning. Since 2015, we have received 16 legacy gifts totaling \$1,683, 908. These gifts have enabled us to replace the Lexan covering on the nave windows with tempered glass, develop the 3<sup>rd</sup> street garden, formerly known as the "3<sup>rd</sup> Street Parking," and install permanent backing on the cherry tree panels in Baxter Hall as well as to retire our indebtedness from the major Vision 2020 and Extended Vision renovations.

Just over \$90,000 in Legacy gifts were received in 2023 from Jim Steed, Mary Welker, John Barton and Don Mosher. We are very grateful to those who have indicated that they have made advance plans for legacy gifts to the parish.


